History and Scope: Who we are

Jane Doe Inc.:

- is a state-wide membership advocacy organization dedicated to preventing and abolishing sexual assault and domestic violence

- operates from a gender analysis of sexual and domestic violence within a social justice framework

- was formed by the 1998 merger of the MA Coalition of Battered Women Service Groups (founded in 1978) and the MA Coalition Against Sexual Assault (founded in 1973)

- is recognized within the Commonwealth of Massachusetts as an authority on these issues and works closely with state agencies, the Executive and Legislative Branches of State Government, other state and national advocacy organizations, and federal agencies and elected officials.

Who we serve:

Our membership is comprised of more than sixty community-based sexual assault and domestic violence, and/or dual programs across the Commonwealth that provide advocacy support and services for victims/survivors of SA/DV and their children.

What we do:

- advocate at the state and national level for public policies and practices that improve options for victims and survivors and the local programs that provide support and services.
- work closely with other state coalitions and national organizations to remain current on developments in the field and to influence policy and practice.
- look to the margins to identify victims, members, advocates communities and populations that may be under represented, overlooked, disenfranchised or otherwise made invisible.
- serve as a statewide resource center on sexual assault and domestic violence. Jane Doe Inc. provides networking opportunities and support; technical assistance, training, and information; and facilitates communication among the membership.
- provide a collective voice on the issues of sexual and domestic violence in framing them as human rights and social justice concerns that require both short and long-term solutions.
- work with our member programs in order to understand the impact of sexual assault and domestic violence on victims and local communities as well as the impact of current systems, practices and policies on victims and their children, in order to create effective and life sustaining solutions.
- recognize that coalitions are most effective when they are member centric and victim focused to best understand the experiences of survivors which drives our prevention, technical assistance and policy advocacy actions.
